HOUSEHOLD HAZARDOUS WASTE COLLECTION

The City of Independence is holding their annual Household Hazardous Waste Collection on **Saturday, May 4th from 9am to 2pm** at their City Hall, located at 1920 County Road 90. Hennepin County will not be on site this year. Independence will have a vendor there to take the following items (ID showing Hennepin County residence still required): Auto, vehicle and household batteries (FREE); Electronics (\$5-25 depending on item and size); Fluorescent Tubes/Bulbs (Do NOT tape together-in original packaging or surrounded by cardboard-must be dissembled and ballasts disconnected from housing unit. Bulbs 4' and under - \$.50; Bulbs over 4' - \$1; ballasts - \$2; light fixtures - \$10); Propane tanks (under 3' -\$5, over 3' - \$10).

CITY WIDE CURB SIDE CLEAN-UP

Loretto residents can take advantage of the City's Curb Side Clean-up by placing your items curb side by **6am on Tuesday, May 14th.** Items NOT accepted are: paints, hazardous waste, asbestos, propane tanks, and fluorescent bulbs. For bulk items such as couches, mattresses, or construction debris, please call Randy's at 763-972-3335 to make arrangements for pickup - have your credit card number ready as there is a charge for pickup of bulk items.

CURB SIDE LEAF & GRASS COLLECTION

Curb side leaf and grass collection will take place on **Tuesday, May 21st.** Brush must be tied in 3' x 3' bundles. All yard waste must be in compostable bags. Please stop by City Hall for your free box of compostable bags, while supplies last!

HENNEPIN COUNTY FIX-IT CLINICS

SOLID WASTE DISCLOSURE FORM

The Waste Management Act, as amended in 1993, requires that a person who collects construction debris, industrial waste, or mixed municipal solid waste for transportation to a waste facility shall disclose annually to each waste generator from whom waste is collected the name, location, type of, and the number of the permit issued by the Minnesota Pollution Control Agency, or its counterpart in another state, for the processing or disposal facility or facilities at which the waste will be deposited. The collector shall note both the primary facility at which the collector most often deposits waste and any alternative facilities regularly used by the collector.

Pursuant to Minnesota Statute 115A.9302, Randy's Sanitation, Inc. hereby discloses that mixed municipal solid waste collected will be delivered to one of the following facilities during the time period January through December. If an additional facility becomes either a primary facility or an alternate facility during this period, the hauler is required to provide you with updated information within 30 days. In addition, the Minnesota Legislature requires Minnesota waste haulers make the following disclosure to their customers:

"You <u>may</u> be responsible for any liability that results from contamination at the facility where your waste has been deposited. Minnesota <u>believes</u> that its waste management system provides substantially more financial and environmental protection than depositing waste in landfills in other states. Managing your waste in Minnesota may minimize your potential liability."



WINTER PARKING REMINDER

Loretto residents are reminded that winter parking rules are still in effect (November through March). On-street parking is prohibited on all city streets between the hours of 2:00am and 7:00am, with the exception of Medina Street, where parking is prohibited between 2:30am and 6:30am year-round.

TRANSIT LINK

Transit Link is a service that provides rides for local area residents to medical appointments, shopping, work and more. Transit Link is available from 6:00am to 7:00pm Monday through Friday.

To reserve a ride, call **651-602-5465**. (You may reserve a ride up to 5 business days in advance.) Tell the reservationist your destination, and staff will help you determine whether your trip is eligible for **Transit Link** or if you have regular transit route options available. Be sure to tell the staff if you are going to a scheduled appointment time. Customer service staff will also help you through the process of riding **Transit Link** and regular transit buses.

VACATION HOME CHECKS

If you are planning a trip out of town, the Medina Police Department provides a "House Check" to Loretto residents. Call the Medina Police Department at 763-473-9209 to have your house placed on their list. The police will check your home by occassionally driving up the driveway and walking around the house while you are gone. If any problems are noticed, they will notify your contact person.

CITY OF LORETTO NEWSLETTER

HYDRANT FLUSHING

City water hydrants will be flushed on the second Wednesday of each month, beginning in April and going through October. Flushing will begin at 8:00am and finish by 11:30am. Residents may experience low water pressure during this time. The flushing process may loosen rust sediments in the water lines, so please check your water prior to doing laundry.

SWIFT NOTIFICATION SYSTEM

Beginning with hydrant flushing this year, we will be using our SWIFT Notification System to alert residents to important information going on in our city. If you haven't signed up to be on this alert system yet, please contact City Hall with your information (phone numbers and/or email address). Each residence is allowed up to 4 phone numbers, one text number and one email address. If you are leaving a message, please also give the name of your mobile carrier if you wish to receive text messages for your alert (i.e. AT&T, Verizon, Sprint).

SELLING YOUR HOME?

If you are selling your home, please contact City Hall to arrange a final meter reading for your utility bill. This gives us notification to finalize your bill.

EAST RAILWAY STREET

Please be aware that East Railway Street (by the Post Office) is a **ONE WAY STREET**. We have received complaints that drivers are not following the street signs. This could cause serious injuries to drivers coming onto East Railway from County Road 19, expecting the full right of way. Please follow the street signs to keep us all safe.
